

#### **Executive summary**

In response to COVID-19, the NHS has launched one of the largest public vaccination programmes ever. To help local services and national policymakers understand how they can improve the vaccination programme, Healthwatch County Durham circulated and promoted a survey, developed by Healthwatch England in February 2021.

The survey questions aimed to help gauge public attitudes to, and experience of, the vaccination programme.

#### **Survey results**

The NHS is doing everything it can to deliver COVID-19 vaccines, but there might be things that could be improved. We wanted to know:

- What people in County Durham think about the vaccine programme
- Whether they would be willing to have the vaccine if they had not already and if they have already had the vaccine
- What they thought about information on the vaccination programme

We are using the results to help local services better target communities and improve their vaccine service.

We received 260 responses to our survey, which were received all from the on-line survey. 206 (79%) of the people completing the survey were female and 51 (20%) were male with 2 people preferring not to say. 249 people completing the survey were "white British", 5 people were "any other white" while 2 people preferred not to say.


#### Observations and Recommendations

From the information provided in our survey we have made the following observations:

- A high percentage of people who completed the survey are very positive about vaccines in general and in particular about receiving the COVID-19 vaccine. There was praise for the staff, volunteers and the organisation of the vaccination programme
- This positive view could be because of the positive adverts/messages promoted by the NHS nationally and locally or could be because people wish to protect friends and family as 86% of those completing the survey said this was their main reason?



- Being able to access appropriate transport to vaccination centres was one of the major concerns raised and we are aware that NHS County Durham Clinical Commissioning Group has arranged transport for some vulnerable people to vaccination sites which is very positive
- There were a small number of negative comments about the order in which people were called for the vaccination and some concerns about carers not being able to get the vaccination sooner
- Because all the survey responses we received were from white British or other white ethnicity we are unable to reach any conclusions about the attitudes or views of Black Asian and Minority Ethnic (BAME) communities to the vaccination programme
- 8 people said they thought the government should do more about misinformation and scaremongering





#### Background to our work



The Government's COVID-19 vaccines delivery plan aims to vaccinate tens of millions of people. We promoted this survey to support feedback of rapid insight to Government and local services about how the vaccine programme is working. The survey helped us to gather information about people's attitudes to COVID-19 vaccines and communications. The questions were

based on those the Department of Health and Social Care are using to gauge take-up of and attitudes to the vaccine.

We've focused the questions on attitudes to and communications about COVID-19 vaccinations for two reasons:

- Only a small percentage of the population had received the vaccine at the point at which we promoted the survey and, due to targeted age demographics, those that have received it would have been less likely to access an online survey
- Surveying attitudes and communications allowed us to see who may be sceptical of the vaccination programme and how communications can be delivered with their concerns in mind. For this reason, it was really important to record the demographics of respondents as fully as possible

#### What we did and what we found




To collect people's views on the COVID-19 vaccine we used social media, published our survey on line via our e bulletin. Due to the current COVID restrictions there was no face to face engagement. The survey was developed by Healthwatch England for each local Healthwatch to use the questions to gather information locally about people's attitudes to COVID-19 vaccines and communications.

Of the 260 that completed the survey 204 people were very positive in general about vaccinations with 40 people being fairly positive. 110 people who had completed this survey had already received their COVID-19 vaccine, however a further 134 confirmed that they definitely would have the vaccine when offered it. Only 10 people told us they would probably not/definitely not/not sure about having the vaccine when offered.



66.5% of people completing the survey told us nothing would prevent them from getting the COVID-19 vaccination, however 20% said that having to get a taxi or public transport to the vaccination site might stop them from getting it.




Where people indicated "Other reason" this is a summary of their views:

- Being extremely clinically vulnerable
- I think it's been made too quickly with little research into side effects
- I would be discouraged from getting the vaccine if it seemed as if the vaccination centre was not Covid-secure (e.g. distancing being observed, thorough cleaning of chairs, touch points etc)
- Being missed off a vaccination list an therefore not called for a vaccine appointment
- Concern about reports that UK is greedily buying up the vaccines at the expense of other poorer countries who desperately need it
- Being unwell and unable to have it
- weather disruption
- If statistics showed that the vaccine caused problems with some people with underlying health conditions
- I'm pregnant
- not being able to have it at my GP surgery where I have no doubt about competence of staff
- If the time available was when I don't have childcare I would struggle to attend the vaccine appointment




- Having to stand in a queue for a period of time would be difficult for me
- The way this question is formed. It is not necessary or helpful to say offered free of charge. It is not actually free all working adults contribute to the NHS most of their working lives
- If my husband was off work to take me
- Don't need it-age fitness not required

The graph below shows the main reasons why people wanted the COVID-19 vaccine.





For those who have been vaccinated, below are the reasons why they decided to go ahead.




260 people answered the question around where they have mainly seen or heard information about the COVID-19 vaccine, with the most common themes being:

- An NHS or government website (63%)
- TV/Radio (73%)
- Newspaper/online news websites (54%)
- Government press conference (46%)
- Social media (39%)

We asked all respondents what they thought about the information that they have heard or seen, 203 people (78%) thought it was positive.

Mixed messages in relation to what people thought about the information from the NHS or the Government about the vaccine and its roll out and how it had been communicated.





#### What else did people think was important?

In total we received 260 completed surveys. At the end of the survey people were able to tell us anything else about the vaccination programme that they thought was important.

82 out of 260 people added information. There were a mixture of positive and negative comments about the vaccination programme.

The key themes from their views are listed below:

- 15 People were really pleased with the way the vaccination programme was going in general, some already having been vaccinated and others still waiting
- 2 people mentioned they were pleased with the information they had received about the vaccines, this included the government, local authority and their GP surgery
- 10 people commented about how well they thought programme was organised, including the great work of the staff and volunteers
- 5 people talked about waiting to be contacted, some being confused between making the appointments themselves or waiting to be contacted by their GP, with one person thinking the vaccination centres should be open 24/7
- 8 people mentioned waiting for their second vaccination and of this 6 people thought the time between appointments should be less than 12 weeks



- There were a number of concerns about the cohorts and order in which people were selected to be vaccinated.4 people felt there should have been more clarity or inclusion for people with underlying health conditions and 5 people specifically mentioned carers and their opportunity to be vaccinated sooner. Only one person mentioned that they thought they should have had a choice about which vaccine to have
- There were a lot of comments about the information available about vaccination. 8 people thought the NHS/government should do more about scaremongering and misinformation or that the news and social media should be more responsible. One person felt more should be done to encourage people from BAME communities to have the vaccination
- 5 people felt they should have been given more information about the side-effects of the vaccines and what to expect after you have been vaccinated
- 4 people were concerned about being offered the vaccination at centres that were too far away

"Had the first Pfizer vaccination, the information leaflet given at the appointment states 21 days interval but actually have to wait 12 weeks. This is a concern as I feel the second should have been given following the trial guidelines. Now I feel unsure about how effective it will be"

We asked people to provide us with the first half of their postcode to enable us to identify which localities were represented. The main postcode areas are DH1, DH7, DL5, DH8, TS21 and DL17.

Of the 260 people who completed our survey 259 provided us with their ages which ranged from under 18 to 75+. In addition 206 of respondents identified as females and 51 as males with 3 preferring not to say. 249 confirmed they were white British, 5 as any other white and 6 preferred not to say.



#### **Conclusions**

In conclusion we found the majority of people were happy with the rollout of the vaccine programme and the information that they had received, there was praise for the staff and the organisation of the programme.

Although there were some negative comments around the order in which people should receive their vaccines and concerns raised about carers not being able to have the vaccination sooner. Some people also mentioned they thought more should have been done to counteract misinformation and scaremongering

"The organisation has been incredible to deliver the vaccine and there's nothing to fear on receiving the vaccine"


